PROJECT DESCRIPTION

REMAKING is a project funded by the European Horizon Europe Programme that aims to explore remote work as a driver of social, economic and territorial transformation. Born in response to the major changes of recent years – from digitalization to the pandemic and geopolitical crises – the project seeks to understand the multiple impacts of remote work on people's daily lives, on business organization, and on the future of territories.

Through a participatory approach, REMAKING aims to analyze four different forms of remote work (digital nomadism, post-pandemic work, high-tech professionals, and forced remote workers) across seven European countries (Italy, Greece, Portugal, Germany, Czech Republic, Ukraine, and Ireland), with a particular focus on medium-sized cities and rural areas.

OBJECTIVES

The core objective of the project is to provide policymakers with tools and knowledge to address the transformations related to remote work through targeted and territorially-aware public policies. REMAKING is based on the belief that remote work, if properly understood, can become a structural driver of change in social, economic, and spatial terms.

By carefully analyzing ongoing megatrends and recent shocks, the project aims to highlight both the challenges and potential of remote work, promoting a multi-level and transnational understanding of its implications.

ACTIONS

To achieve its goals, REMAKING adopts a participatory research approach, actively involving local communities, businesses, institutions and workers. The project is structured around four case studies, each dedicated to a different form of remote work. These cases will compare medium-sized cities and rural areas, offering a comparative perspective useful for identifying effective intervention strategies. Through this analysis, REMAKING aims to strengthen resilience and promote the socio-economic development of territories, contributing to the improvement of quality of life and the sustainability of new work models.

The project also includes dissemination activities and the exchange of experiences across Europe, with the goal of fostering the sharing of good practices and building a shared vision for the future of remote work in Europe.
